

BORDER COLLIE CLUB OF NSW INC MINUTES OF THE GENERAL MEETING HELD AT ERSKINE PARK ON TUESDAY 2^{ND} JUNE, 2009



Meeting Opened: 7.45pm by L. Somers. Apologies to the members present for the late start as several committee members were delayed.

Attendance: Attendance and apologies as per book.

Moved: B Farrell Sec: A Moy Carried

Minutes of the previous general meeting – as tabled and appearing in newsletter.

Business arising – nil. That the minutes of the previous general meeting held on Tuesday 7th April, 2009 is accepted as a true and accurate record.

Moved: A Moy Sec: C Finch Carried

Reports:

Secretary's Report – as tabled. Item 3 (Dogs NSW correspondence) moved to show business. Item 7 – Puppy Sales – discussed situation with current answering machine arrangements – meeting felt that we should try and maintain the recorded message in addition to the litters being posted to the club's website. Brett Farrell to contact Margaret Rockey to discuss options.

Puppy Sales Report – as tabled – four litters currently listed.

Trial Secretary's Report – Alice Baxter reported on the recent double Duck trial – both trials were combined on the one day, Saturday. Event went well – Colin Webster won both trials. Club will generate a profit from this

weekend despite the extra expenses incurred (portaloo had to be hired!) Full results will appear in Bordertales and on the website.

Tracking Trial Report – Lauren Somers expressed the club's appreciation to Eric Camp for his efforts in running this event. Numbers were restricted due to lack of space as we had to change grounds from Glenfield to Erskine Park because the grounds were inaccessible following the recent wet weather. 50% success rate with one pass and one fail. Congrats to Ann Howard on her success with Track 4.

Treasurers Report – as tabled. Brett expressed concern regarding the potential loss from the last show – final figures not yet in. The hiring costs of additional rings because we could not use the GSD grounds were quite substantial. He also requested that Alice provide a list of stock being held for the end of year reports and also commented on a letter from our auditor regarding queries from the ATO on the 'non profit' status of clubs such as ours. Discussion followed and the meeting resolved that at this stage we feel we meet the requirements to satisfy this status and no further action will be taken.

Hereditary Diseases Committee Report – Karen Galbraith tabled a report on her recent meeting with Karen Hedberg regarding reported cases of glaucoma in Border Collies and also raised concern regarding recent comments by Dr Bruce Robertson regarding glaucoma, gonioscopies and the ACES scheme. Karen Hedberg suggested that our club writes to Dr Kevin Doyle (AVA National) and expresses our concerns and also explains that the matter had been raised by members, was being discussed by all clubs and will be referred to our National Breed Council. Lengthy discussion ensued and the meeting agreed that Karen Galbraith and the HD Committee are to prepare and send correspondence as suggested.

Karen Galbraith also advised that in respect of the Breed Survey, Karen Hedberg requires this submission to be submitted in a specific uniform format and Karen confirmed that the committee was currently undertaking this task. Karen also talked about the recent seminar she attended which was hosted by the Collie club as part of their National event. During one of the session GTG presents some stats of CEA and those relating to Border Collies were very interesting:

Testing of 1000 dogs resulted in 62% normal, 35% carriers and 3% affected.

Moved: A Moy Sec: C Finch That the reports be accepted. Carried

National Breed Council:

Ann Moy advised that we were still awaiting confirmation from Bev regarding the AGM. We had responded that we felt it was necessary to hold a meeting and also that we wanted to undertake a review of the NBC and how best to ensure it achieved results.

The agenda for the National Breed Council conference was tabled and it was agreed that it would be put up on the website and e-mail notification would be sent to all 'e-mail members'. A note regarding access to the information would be included for the current issue of B/tales that were to be mailed out to members. The club requires the voting responses of members to the various issues raised to be received by 30th June, 2009 to enable the committee to discuss at the next meeting and formulate our response to our NBC by the deadline of 11th July, 2009.

Show Business:

Ann Moy tabled the various responses received from Dogs NSW regarding our request to change dates for our April/October shows. The reason for the change was to facilitate a change of grounds for the October show from Castle Hill to Erskine Park and for the April show a change of date was needed to avoid the regular 'clash' with General Specials at the Royal which results in last minute date changes as occurred again this year.

Sadly, despite prolonged negotiations and discussions it appears that we have again been unable to satisfy all THREE Dogs NSW committees which have to agree to the request so it is back to the drawing board.....the meeting discussed various options and Ann will now go back to them with suggested alternatives. The meeting offered our thanks to Ann for her efforts in this situation.

General Business:

Lauren was delighted to report that a couple of members (not currently involved in club activities) had offered their assistance and hopefully this will enable the workloads of a couple of the committee member to be reduced.

Health Update - Glaucoma

Glaucoma in Border Collies

There has been much discussion on several internet lists about 5 cases of narrow angled glaucoma recently reported in Europe in young Border Collies. Three of these were sired by the Australian dog Ellagant Stargate at Ampriors "Neo" and one was sired by one of his sons. Neo, at 4 years of age, has sired 29 litters in Europe so there is a great deal of concern over there. The fifth case is at this stage a trauma induced one affecting one eye only in a bitch descended from the original NZ imports into the UK. If glaucoma does not develop in the other eye then it cannot be classified as primary glaucoma with no known cause as the other 4 have been.

Professor Bedford in the UK has advised the breeders there to test their dogs by gonioscopy to determine if they have the narrow drainage angles in their eyes, known as goniodysgenisis, and if they do he claims that they are "predisposed" to develop glaucoma. His gonioscopy results are graded as "unaffected" or "affected" with the affected ones graded from 1 to 5 with the narrowest angles being graded as 5. All other veterinary ophthalmologists simply grade a gonioscopy as affected or unaffected and do not use the grading system, or they may just make comments about possibly some narrow angles or declare perfect angles. They don't seem to give any sort of consistent comments. Dogs declared "affected" by gonioscopy DO NOT have glaucoma but MAY possibly be predisposed to developing it at some point.

While no dogs graded as affected by gonioscopy have so far gone on to develop glaucoma, the three sires of the glaucoma cases in Europe have all been graded as grade 5 goniodysgenesis. The fifth glaucoma case has also been graded as grade 5 in the eye that does not have glaucoma. The mode of inheritance of glaucoma has not been determined in Border Collies and is believed to be polygenic - not autosomal recessive like CL, TNS and

Despite many enquiries to breeders and vets around Australia and the rest of the world, we have been unable to find any records of other glaucoma cases ever in Border Collies under 5 years of age. The only glaucoma cases we are aware of in Australia were four diagnosed, prior to 2004, as glaucoma with no mention of narrow or open angles. There are two completely different forms of glaucoma - narrow angled and open angled. These dogs, diagnosed between 5 and 10 years of age, were a sire and two of his daughters from different litters plus one other related pet bitch, whose owner had thrown out her papers before we heard about her. Only the known sire and one of his affected daughters had been bred from prior to being diagnosed, and breeders with descendants of these two have regularly tested their dogs over the past five years. Some of the descendants have been diagnosed with narrow angles but none have developed glaucoma despite many now being aged over 11 years. There have been no other cases of glaucoma, that we are aware of, diagnosed in the past five years in Australia, and our ophthalmologists have never before recommended that gonioscopy screening be done to indicate a predisposition to glaucoma.

A member of the BCCs of Vic and NSW who was one of the first ones to hear about the glaucoma cases in Europe, contacted Dr Bruce Robertson at the urging of her ophthalmologist to request a uniform grading system for goniscopy in Australia and for gonioscopy to be added onto the ACES official results. Some ACES vets around the country state that while they can do a goniscopy without doing a full ACES eye exam they are unable to issue any sort of written result unless it is done in conjunction with the full ACES exam at the normal charge(\$65 - \$170) plus the gonioscopy charge (approx \$20 -\$40). The gonioscopy alone without a written report can be done here for as little as \$15 and in the UK they can have a full eye exam done, including gonioscopy for about 23 British pounds.

Dr Bruce Robertson from ACES has now contacted the individual member as well as our sub-committee and the NBCC Health and Hereditary Diseases subcommittee. He has requested an urgent response as to what we intend to do about glaucoma in Border Collies as he needs data to take to an international conference in July. Unfortunately, a response from breeders around the country is not possible in that time frame as most breeders still know nothing or very little about any glaucoma cases or what has been happening in Europe. We all need time to gather information, carefully assess the situation and go through the voting process of the NBCC to reach a democratic conclusion, which will take months not just a few weeks.

We will provide Dr Robertson with as much information as we are able to at this time, but we will be writing a report to the AVA , ANKC and ACES explaining our concerns and outlining what we would like to have available to our breeders who wish to help in researching this condition. We will point out the fact that no official notification of the problem has been sent to the NBCC or the Clubs at this stage and that the constitution of the NBCC involves a lengthy voting process so it will take several months for any sort of official report to be put together by the NBCC. We will state why we do not believe it is appropriate at this stage for glaucoma or goniodysgenesis to be declared a breed problem and will also be requesting that the ACES panel offer gonioscopy only testing for research purposes, on a separate report to the full ACES eye exam at a reduced cost. The fact that blind Border Collies of any age are virtually unheard of in Australia, combined with the data collected by the BCCs of NSW and Vic, from hundreds of adult eye certificates over a 10 year period confirms our belief that Border Collies do not have any significant eye problems as a breed. For these reasons we do not believe that breeders should be forced to have full ACES exams done in order to collect data from gonioscopies. Until we have much more standardised data from gonioscopies done in Australia we will not know if goniodysgenesis is a normal variation in the eyes of Border Collies or if it is in fact a reliable indicator to a risk of glaucoma.

Nominations for Committee

It's that time of the year again to call for nominations for the club's committee for the upcoming year. All positions become vacant at the **Annual General Meeting on 1**ST **SEPTEMBER 2009**. The club needs your help and also needs new ideas and people. If you can help and are able to give up some of your free time for the upcoming 12 months then please fill in the nomination form on the following page and nominate for a position on the committee for the 2009-2010 year. To give you an idea of what the responsibilities are for each of the positions there is a brief job description shown below.

President – Chair meetings, open and close shows/trials and act as master of ceremonies; represents the club at functions when requested to do so by the committee; take over duties or accepts responsibility of transferring those duties to another member.

Vice President – Stand in for the President in the event of his/her absence.

Secretary – attend to all club's correspondence; carry out duties in accordance with the requirements of the RNSWCC, and club's constitution and handle general club inquiries.

Assistant Secretary – Record minutes of all club and committee meetings; supply copy of minutes to President, Secretary, and Treasurer, stand in for the secretary in his/her absence.

Treasurer – Carry out duties in accordance with the club's constitution, including handle all of the funds of the club and ensuring that all accounts are paid.

Publicity Officer – Collate, print (or arrange for printing to be done) and send out Newsletter as requires; prepare any other printing as requested by the club.

Show Secretary/Trial Secretary – Contract judges; submit draft show/trial schedule and advertising to the RNSWCC at least 6 months prior to show/trial; if required, arrange accommodation and transport for the judges; receive and catalogue entries; send out entry cards at least ten days before show/trial; arrange for vetting officer for trial; obtain and complete all documentation as required by affiliates constitutions and send to Canine Council; provide Publicity Officer with marked catalogue after show/trial; organise any critique arrangements as requested by the club; provide memento to the judges.

Show Manager/Trial Manager – Arrange stewards; arrange with caretaker erection and subsequent dismantling of directional signs in street; organize parking arrangements including an attendant; liaise with Show/Trial Manager regarding the ring placement; ensure that all rings and equipment are dismantled and put away after the show/trial; assist the Show/Trial secretary and, if necessary, arrange for an erected tent to be provided for Show/Trial Secretary; entertain judges when they arrive; arrange and instruct photographer and/or video cameraman; ensure grounds are left clean and tidy after show/trial and that grounds and buildings are locked as prior to show/trial.

Trophy Steward – Record all notifications of show, obedience, tracking and endurance title throughout the year; purchase title and point awards; purchase trophies for show/trial; if required, select another member to confer in trophy selection; endeavor to secure sponsorship for the show/trial.

Property Officer – Store and maintain club's property, including Club's photographic records but excluding promotional items.

General Committee - Be an active member of the committee, lending a hand wherever required and taking on incidental positions as they arise.
