We have, at very short notice, obtained a replacement judge from our 2010 judges list - Mr R Stoate from Victoria - thanks to our show secretary, Lyn Cooke and our treasurer Brett Farrrell for making all the last minute arrangements to accommodate this change.

Sydney Royal will run from April 1 - 14 this year with Borders being judged in conformation on Wednesday 7th and agility and obedience events being held on the final days 12th, 13th & 14th - the club has again donated trophies for Best of Breed, Highest Scoring BC in obedience and best all-round performance in Agility - best wishes to all exhibitors!

As herding training and trialling gets underway for 2010, we have been requested to assist with maintenance work required on the Erskine Park grounds - further details are provided later in this edition of *Bordertales* regarding two upcoming working bees - if you are able to assist in any way I am sure that you will be welcomed with open arms!! Our members are fortunate to have the use of conveniently located facilities so please offer to help if you can. Details of the club's upcoming herding trails (May 2010) will be on the website or you can contact Alice Baxter for further information.

Finally, the committee was concerned to hear that Dr Alan Wilton, a familiar figure to many club members and our fellow committee member - Bette Miller, have recently been unwell and I am sure that all members will join with me in wishing both Alan and Bette a full and speedy recovery.



#### With Ed





# The joys of owning a "Delta Dog"

The Delta Society "Pet Partners" scheme has over 600 trained Volunteers and accredited dog teams. These teams visit over 300 hospitals and aged care facilities each week. During 2009 Ukko and I were thrilled to complete the necessary training and checks to enable us to begin our work within the Children's Hospital at Westmead.

Originally the feeling that I wanted to 'give back' something to the community was quickly followed by the idea of joining Delta. I had seen snippets from time to time about their work and I do not need any convincing about the ability of dogs to help with the healing process. Ukko in my eyes was the perfect candidate, a dog who had been doing unofficial therapy work with the students of my paid job for years.

On our first visit it was soon made clear that my simple idea of children possibly missing their own pets while in hospital might like a visit, and did not do justice to the work done by the Delta dogs and their volunteers. At Westmead the 'Dog Squad' meet in the front foyer and

await their instructions for the visit of approximately one hour (the work the dogs do is very taxing due to the intensity of sounds, smells and sheer numbers). Six dogs each week, two per floor bring joy, laughter, encouragement and love to the amazingly brave children and their families. Often the children are in hospital for an extended amount of time, so the visits are the highlight of the week to many animal lovers.

I soon understood that the star of this show would be Ukko, and that he could be trusted to make sound judgement on whether a child needed him to be a clown and do some tricks, or alternately just lie next to them on the bed and enjoy a cuddle. He is able to get children to take their medication, or do their often painful physiotherapy, and sometimes encourages a small miracle to take place.

Children feel safe to tell dogs many things that they might never share with anyone else. I have been witness to smiles that would melt any heart, and many moving moments. Each week I leave feeling a strange mix of guilt and joy... as any volunteer will tell



you, somehow you leave getting more out of the experience than the people you intended to help! Ukko loves the days when the Delta scarf comes out. It is a joy to watch him at work. He was born with a special ability, and all who know him have seen his special "bum dance" - a very strange dance of joy that has captured the hearts of all and has helped many children to giggle uncontrollably on what could have otherwise been considered a very bad day.

## **2009: The year that was...**

So it is that another year as been 'run and won' for the Australian dog show calendar, and as usual 2009 saw the Border Collie proudly represented in all states of Australia! We are fortunate as a breed to have many exceptional representatives amongst our ranks that continue to take top honours at all breeds, group and specialty level. In recognition of those Border Collies who have been doing so well at promoting our beloved breed, we take a moment in this issue of *Bordertales* to make special mention of the final 'winners and grinners' of the 2009 DogzOnline Point Score and to offer our congratulations on behalf of the Border Collie fraternity to the successful entrants of this competition.

To begin with the **National Breed (All Breeds)** competition, it is heartening to see a great many Border Collies achieving consistently in the All Breeds ring! There were 44 Borders entered in last year's competition, spread out over 41 placings, with Victoria and Queensland being well represented in the final results. To qualify each of these dogs had to be awarded a Best In Group, Runner Up Best In Group, Best In Show or Runner Up Best In Show (All Breeds) award during 2009, and points were allocated to each entrant based on the number of exhibits entered according to their respective win. After a hotly contested year, the top three national placings ultimately came down to three Victorian entrants. Congratulations to the eventual winner of the 2009 National Breed (All Breeds) competition, **Ch Innisman All Said N Done** (Sullivan & Hall), who notched up an impressive record of Best In Show, Best In Group and Runner Up Best In Group awards between June and December. If his name sounds familiar to you, 'Derby' has

also added to his credit Best In Show at the 2<sup>nd</sup> Border Collie National, as well as finishing overall No.9 Working Dog in Victoria for 2009. It was a tough competition for the minor placings, but in the end second place was won by **Gr Ch Glentress Anastacia** (Adams) who likewise boasts an impressive show record for 2009, followed closely by **Gr Ch Khayoz Perfect Crime** (Khayoz Kennels). NSW's highest placing entrant was only just pipped at the post for a top three ranking, with **Gr Ch Yarrancoly Incite A Riot** (Baldwin) finishing the competition in fourth place. Overall, it was a very close competition. It was great to see the boys and the girls sharing the honours across the board, and in almost every state – proof (as we all know) that a good Border Collie can win anywhere!

Now onto the **National Best Of Breed** competition, which recognises wins at a breed level, we had almost 100 breed entrants in the 2009 point score, eventually spread out over 74 placings. Points in this section were allocated according to Best of Breed or Runner Up Best of Breed wins throughout the year, with points tallying the number of dogs beaten at a breed level. It should come as no surprise then that the Best of Breed point score was again a very close competition, with less than 40 'dogs' separating the top three placings in the end, and another three entrants following close behind. Congratulations to the 2009 Best of Breed Winner, **Ch Danari DateWith Destiny** (Wheatley) from NSW, who took home top honours. 'Zali' enjoyed some lovely wins during 2009 that contributed to her overall success in the point score, which included Runner Up Best In Show at the 2<sup>nd</sup> Border Collie National and Runner Up Best of Breed at the Sydney Royal. As in the National (All

Breeds) competition, it was a close finish for second and third place. However in the end it was the well-performed **Ch Bordalace Flash N Dash** (Cowin) also representing NSW who finished in second place, followed by **Ch Innisman All Said N Done** (Sullivan & Hall) close on his heels in third position.

The **Rising Star (Breed)** competition (formerly Puppy of the Year) is certainly one of the most popular on the DogzOnline system, and is a great way to distinguish the achievements of the future stars. In this competition fixed points are allocated on a sliding scale for dogs in the Baby, Minor, Puppy and Junior classes, with maximum points being awarded for a Class In Show win, and less for a for a Class In Group or Class of Breed win. These Rising Stars compete at breed, group and all breeds level. Again there were a

great many Border Collie entrants in the 2009 competition, proudly representing every state in Australia. Congratulations to the eventual winner of the Rising Star (Breed) competition, Ch Bordalace Day Dream Believer PT (Cowin) who won the competition with an amazing record of Class In Group and Class In Show awards throughout the year, from the Baby to the Junior class. 'Simon' also went on to represent our breed in the group and all breeds sections, finishing the year as Australia's No.1 Working Dog Rising Star, and No.8 NSW Rising Star All Breeds – no small feat for any breed! In second place for the breed competition was Ch Khayoz Lady OThe Nite (Tidswell & Leibhardt) from SA, who was also SA's No.1 Working Dog Rising Star and the state's No.4 Rising Star All Breeds. Third place was awarded to Ch Gremaric Speechless (Richens) of Queensland, who finished the year as QLD's No.3 Working Dog Rising Star. Congratulations to all concerned - it is great to see our youngsters doing so well!!

Last but certainly not least is the 'ADVANCE' Breeder of the Year Competition. Introduced to the DogzOnline point score system in 2008, this competition recognises the achievement of Australian Breeders at a breed, group and all breed's level based on titles and awards achieved during the year. The Border Collie competition had 18 entrants in total for 2009. Well done to the eventual winner of the Border Collie Breeder of the Year, John & Kate Valk of Khayoz Kennels! With several Championship titles, a Grand Championship title, and many In Show and In Group wins with their team, Khayoz have had a wonderful year. In second place was Glentress Kennels (Adams) who also celebrated a successful year in 2009. Trucharm Kennels (Leslie) were the proud recipients of overall third place. NSW's top entrant was the fifth place winner, Libertybrook Kennels (Bayliss) from western NSW. It is a rare moment that we have the opportunity to give a 'pat on the back' to people behind the dogs, so this is a moment we share to recognise the achievements of our fellow Border Collie breeders, exhibitors and friends. Well done to all!
