The rest is history as fate was going to make sure I became a Border Collie owner when on the 9/8/1987 out popped my Clancy the love of my life. Never have I had a dog that I loved more than that dog, and my love for the Border Collie breed was then firmly entrenched.

My first Bearded Collie arrived in 1984, and at first my Borders thought the Beardies were a bit of a joke, but I feel over the years that the Beardies have taught the Border Collies a sense of humour and enjoyment of life. Here's how it will work:

- There will be **3 categories**:
 - Border's at Work: Action shots of your Border Collie at work, which may include herding, agility, obedience, fly ball, etc.
 - Border's at Rest: Portrait shots of your Border Collie at rest, which may include head shots, family portraits, holiday snaps, etc.
 - Border's at Play: Candid shots of your Border Collie at play, which may include funny photos, dress ups, holiday snaps, etc.
- Obviously, the photograph must feature a Border Collie. No stacked 'show' photos please.
- Entries will cost \$1 per entry. Details of payment will be supplied upon submission.
- The photo must be taken by an amateur photographer, and it must be one that you have taken, or has been taken of your dog. If it is a picture of someone else's dog or someone else's photograph of your own dog, please make sure you also have their permission to use it before submitting. The submission must be a member of the club, or if under 16 years of age a child of a member. You can enter as many photos as you like!
- The competition will run for 3 months (July, August & September). There will be 5 Monthly Finalists for each category which will be decided by the BCCNSW Committee. Monthly Finalists will be published in Bordertales.
- All Finalists will be on display at the 60th Anniversary Show & Trial in October. The Grand Final will be judged by a Mystery Judge to be advised on the day.
- Our Grand Final judge will award 1st, 2nd and 3rd for each category, as well as a "Grand Champion" of the overall competition.

Show and Trial Secretary's Report:

As of 31/5/10 I have still not been able to contact Bill Almond to confirm his written acceptance to judge Agility at our October show. However, I have made contact with Jake Blight (via e-mail) to check his availability to judge and am awaiting his answer. I also contacted Mr A Roach, Mr T. Griffen, Ms P Walsh, Mr M Williams who were on the list and none were available. Pending Jake's reply I will approach Margaret Foord and Ms H Mosslar who are the last on the list of nominations and will advise the committee the outcome. If I have any further problems I will ask the committee to assist in securing a judge.

Judith Walder (Obedience) has also advised that she is going into hospital to have a hip replacement. She was due to go in August which would have made her unavailable for the October show, but as of 31/5 she is trying to bring that forward by a month or so which would allow her to still judge Obedience and she has asked me to keep her name down as the judge. I have, nevertheless approached two other judges to keep on standby in case Judith is not able to judge.

I have confirmed with Kim from Naturally Wagging that she will kindly sponsor the October show by way of providing small gift boxes of products for all our winners valued at between \$15 and \$20 each which is great news as her products are all Australian and natural. She provided the gifts at the recent Working Dog Club and they were very well received. I am still trying to secure further sponsorship, particularly a food sponsor and will advise when and if that happens.

I have started to sell the raffle tickets and so far this has been very well received. If anyone on the committee wishes to assist at any shows particularly if they are going to country shows over the next couple of months, please let me know and I will print off the tickets for them to sell and send them or deliver them.

<u>National Breed Council Reps:</u> Check if Brett wants to go to AGM. Judy to forward voting on NBC Conference Items to NBCC.

<u>Hereditary Diseases Committee Report:</u> Tabled. Also working on doing a health survey. ACES Breed submission to go on members part of website. Likewise our response. Also do an intro and synopsis re ACES and Gonio for Bordertales.

The subcommittee recommends the following response to Dr Bruce Robertson re Breed Submissions under the AVA-ANKC Australian Canine Eye Scheme (ACES) July 2006 – June 2009. The Breed Submissions re Border Collies and the response are to be placed on our website.

"Your report states that 11 dogs were affected by goniodysgenesis from a total of 105 dogs that have undergone gonioscopy. We note with interest that none of the dogs examined were diagnosed with glaucoma. This corresponds to our figures previously submitted to you. For your information we have enclosed a copy this previous letter. We are still waiting for a response to the matters raised in the letter.

We reiterate that we wish to conduct gonioscopy only clinics, at a reasonable price, to gather statistical data about goniodysgenesis. At this stage it appears that none of the ACES panellists are prepared to help us in this endeavour.

We also note that your report mentions puppies affected by choroidal hyperplasia and detached retinas. What you failed to mention is the DNA status of these affected puppies. Could you please provide this information. If in fact the DNA status for CEA was not known then the clinical observations have no bearing on the relevance of the DNA test that will be a requirement for registration from 1 January 2011. You have also made mention of "distichiasis and a few focal cataracts" but have not mentioned the numbers affected or the significance of these conditions. We have never seen or heard of these being diagnosed in puppies in the decade where we had all litters examined. Could you also advise what eye conditions are not able to be detected in an adult dog but can be detected in an 8 week old puppy.

We are currently undertaking a survey with Border Collie owners of eye certificates previously issued by current ACES panellists. As no official records were kept of these results we are keen to find out what eye disorders were detected in our breed. From the over 800 eye certificates our club collected previously we only had one dog affected with any eye disease other than CEA. Until the new survey is completed we cannot make any recommendations to breeders about the need for full ACES eye exams.

As the ophthalmologists didn't keep any records to back up your recommendations how can you expect our breeders to undertake vast amounts of expensive testing in a breed where we rarely have any sight defects.

Your mixed recommendations for testing are very contradictory:

"At least one mature age exam should be carried out, preferably **between 18 - 24 months**, whether or not gonioscopy is requested." (Glaucoma is our main concern at the moment).

"It is probably not necessary to test every adult animal for emerging eye conditions every year, especially in this breed where most conditions are likely to have shown up by four or five years of age. The first adult exam should be carried out no later than 12-18 months of

age then repeated at least every second year through to eight years. Any active breedingage animal (dog or bitch) from which a litter is planned in the near future needs to be able to produce a current ACES Certificate, i.e. updated within the last 12 months."

These contradictions leave us unable to give any recommendations to our members.

Also, it is unfair to make such breed submissions when we feel that our concerns as noted in our previous correspondence have been ignored. Our members need to be met half way by veterinary ophthalmologists if they are to get some idea of the real status of goniodysgenesis in Australian Border Collies.

All the data that we have does not suggest that there is any problem, and until you make it possible via reasonably priced clinics to gather such data, we cannot recommend that our members follow either of your recommendations. We have ALWAYS been proactive on breed issues, but we have taken the approach of investigating and gathering statistics so we can give informed advice to our members. We would be failing them if we did not gather information and verify your submissions.

Indeed, the feeling amongst Border Collie breeders is that there has been no real effort to help us establish whether goniodysgenesis is a breed problem. Another point that has been raised, and we think is very valid, is that while some dogs may have narrow drainage angles, none of these dogs have gone on to develop glaucoma. So we query if such a condition will inevitably result in glaucoma.

Finally, it is our unpleasant duty to advise you that many breeders feel that the ACES exam is nothing more than an income producing scheme for the ophthalmologists, and that now we have a DNA test for CEA, this is a way to once again get Border Collie breeders to hand over a lot of money for unnecessary tests. We would like to refute this argument, but if your colleagues cannot help us with a reasonably priced test for goniodysgenesis, we cannot do so."



Show Secretary/Trial Secretary – Contract judges; submit draft show/trial schedule and advertising to the RNSWCC at least 6 months prior to show/trial; if required, arrange accommodation and transport for the judges; receive and catalogue entries; send out entry cards at least ten days before show/trial; arrange for vetting officer for trial; obtain and complete all documentation as required by affiliates constitutions and send to Canine Council; provide Publicity Officer with marked catalogue after show/trial; organise any critique arrangements as requested by the club; provide memento to the judges.

Show Manager/Trial Manager – Arrange stewards; arrange with caretaker erection and subsequent dismantling of directional signs in street; organize parking arrangements including an attendant; liaise with Show/Trial Manager regarding the ring placement; ensure that all rings and equipment are dismantled and put away after the show/trial; assist the Show/Trial secretary and, if necessary, arrange for an erected tent to be provided for Show/Trial Secretary; entertain judges when they arrive; arrange and instruct photographer and/or video cameraman; ensure grounds are left clean and tidy after show/trial and that grounds and buildings are locked as prior to show/trial.

Trophy Steward – Record all notifications of show, obedience, tracking and endurance title throughout the year; purchase title and point awards; purchase trophies for show/trial; if required, select another member to confer in trophy selection; endeavor to secure sponsorship for the show/trial.

Property Officer – Store and maintain club's property, including Club's photographic records but excluding promotional items.

General Committee - Be an active member of the committee, lending a hand wherever required and taking on incidental positions as they arise.
