### PRESIDENT'S REPORT

In October, 2006, the club's president Tania Piercy resigned mid term and I accepted the nomination to fill that position.

My thanks to the standing committee at that time who provided me with initial assistance and who have continued to work well together and make my job so much easier.

The past ten months have been very busy for our club but I think the efforts put in by the committee and our hard working members have been rewarded. Achievements for the club during this time include:

**Feature Breed – Sydney Royal** – where the club was able to showcase our breed to the general public every day during the fortnight of the Royal Easter show.

**Championship show/trial** – The April show was well supported and returned a profit for the club. As this show/trial was within one day of our judging at Sydney Royal this year, the club included several additional 'events' to reward exhibitors and triallers who enjoyed success at both the Royal and our club show and also incorporated a day of activity at Erskine Park which included a herding seminar, BBQ lunch and sessions providing an introduction to obedience and tracking.

**National Breed Council Meeting** – the club hosted the annual general meeting of the NBCC in Sydney in July.

**Herding Trials** – the club successfully hosted our first herding trials in July and also saw a number of our members obtain their herding judge qualifications this year.

**Tracking trials** – We also held our two annual tracking trials in June – our thanks to Gillian and Graham Elven for organising these trials each year.

**Breed Lecture** for aspiring Working Dog judges – the club hosted a successful lecture night at Erskine Park and will continue to provide assistance to the judges training scheme via upcoming field nights.

Julie Grey continues her work with the **Border Collie Rescue** service and the club was pleased to be able to provide her with ongoing financial assistance during the year.

The club provided a \$500 donation to a family whose daughter is suffering from **Battens Disease** and this story was featured in various publications providing very positive exposure for dog clubs in the community.

We have recently made a further donation to the Battens Research Foundation to assist in their continued research into this disease – a small thank you for the initial support our club received for DNA research into Ceroid Lipofuscinosis (CL).

Our thanks also to Dr Alan Wilton and his University staff for their ongoing efforts with research projects for Border Collies which saw another successful DNA test established this year – this time for **Trapped Neutrophil Syndrome** (TNS). Our breed is setting the benchmark for research and DNA testing and will now be able to reap the benefits of these fantastic scientific advances for many

generations to come. Thank you to the many BC fanciers around the world who have provided assistance – financial and otherwise - to these research projects.

There is a lot of work associated with the success of all the above mentioned projects – the club should be proud of their dedicated membership.

In closing, I am delighted to see that a number of our current committee have agreed to stand for another term – thank you! To the outgoing members, thanks for your past efforts. To the new additions to our committee – welcome – I hope that you enjoy your time with the club and offer our thanks for your interest in our club and in the breed.

Breed clubs such as ours are important – together we can achieve great things – far more than we could as individuals - let us hope that the forthcoming year will provide plenty of opportunities for the club and the membership to enjoy and promote our wonderful breed.

## **Border Collie Club of NSW Treasurer's Annual Report**

Over the period for 2006/07 the NSW Border Collie club has recorded a paper loss of \$9,228.90. This figure is a little misleading and there are a number of factors that should be considered in this loss. Out of this loss \$4,107 of this amount was for National expenses were the income was realised in the 2005/06 financial year but the expenditure did not take place until the current financial year. Also during the year the club made \$3,865.02 of donations during the year to disease research or associated appeals, when in the previous financial year no donation was made to any organisation. There was no income raised during the year towards this amount and it was drawn from funds that had already been allocated to this purpose.

The amount of membership revenue that the club received for the past financial year was down from \$4,970 in 2005/06 to \$3,663 in the 2006/07 period, although the amount of prepaid membership was also down by almost \$800 due the membership renewal form not being available to members before the end of the financial year. One other area of concern is the significant cost escalation in the production of our monthly magazine. The production costs for 2005/06 of \$2,265 has risen to \$4,036 in the 2006/07 period. This is the reason that the postage charge was recently introduced as a way of encouraging members to receive their Bordertales electronically and thus reduce the production costs. I would also recommend that we seek out a number of alternative suppliers to see whether we can obtain a better deal elsewhere.

Another area where costs have been incurred in 2006/07 which have not been incurred in previous financial years is in the area of prepayment of judges flights and accommodation for the upcoming herding trial. In the past the income from the trial and the expense for the judges fees have occurred in the same financial year. With our upcoming herding trial we have already made payments of \$921.00 in judges expenses for which we have realised no income.

Our club shows over the previous financial year have also produced a mixed outcome. Due to some advertising and promotional material in the show catalogue for the April 2007 show we managed to make a small profit on the show. The October show however recorded a significant loss, mainly due to a lower than normal entry. As a club we should examine the expenses at each of these shows.

Other significant purchases or maintenance undertaken by the club during the 2006/07 period include the purchase of a number of fencing panels for herding training and trials. Major maintenance to the clubs equipment trailer and some of it's contents.

Despite the size of the loss I believe that the club is still in a strong financial position but we should question those areas where the costs have increased over the previous 12 months.

## **BREEDING GUIDELINES**

Following these guidelines will ensure that no puppies that you breed in future will be affected by either CL or CEA. From the dates specified, the BCC of NSW will enforce these as conditions for listing litters on puppy sales.

Individual animals may be DNA tested or they may be declared Clear of either condition by pedigree if both parents are Clear. Copies of DNA results must be provided for the parents or clear ancestors when listing litters on puppy sales.

### **CL**

For litters born from 1<sup>st</sup> November 2005 both parents must be DNA typed for CL.  
Permitted matings will be: CLEAR / CLEAR  
CLEAR / CARRIER

The old rules about not mating animals under 2 years and carriers on the pedigree will no longer apply were DNA results are provided. Litters may be listed under either the new rules or the old rules until 1<sup>st</sup> November 2005.

### **CEA**

For litters born from 1<sup>st</sup> January 2006 at least one parent must be DNA Clear for CEA. Permitted matings will be:  
CLEAR / CLEAR  
CLEAR / CARRIER  
CLEAR / AFFECTED  
CLEAR / UNTESTED

Clear Eye Certificates will no longer be required for parents or puppies were DNA results are provided. Litters may be listed under either the new rules or the old ones with Clear Eye Certificates until 1<sup>st</sup> January 2006
