

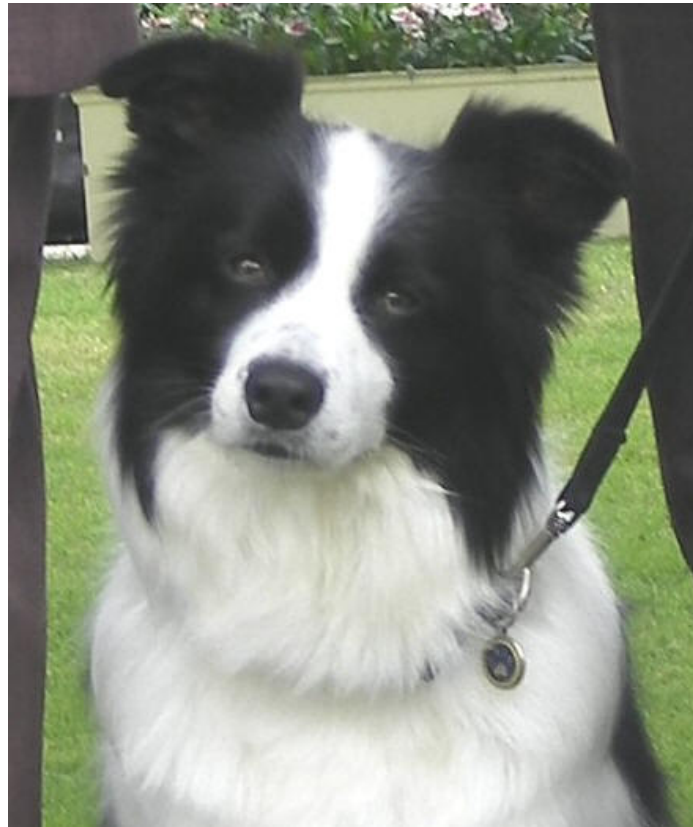

NBCC ITEMS

AGENDA ITEMS FOR THE 2008 CONFERENCE OF NATIONAL BREED COUNCILS

Please return to the Secretary by 20th March

1. (submitted by Victoria)

The ANKC conduct breed survey/referendum with registered owners of each individual breed to confirm that all purebred dogs from main registered purebred parents are eligible for main or limit registration at the discretion of the breeder, and that change of registration status can only occur at the request of the breeder.

Rationale: This motion addresses the problem that has occurred in recent years, where a breeder has determined particular registration status for a dog, and a third party seeks to change the status, and;

- Gives breeders the choice on whether they wish to have progeny from their stock in the gene pool for future generations. It seems quite undemocratic to have a third person dictate what should, or should not be eligible for inclusion in the gene pool that may be against the breeders wishes, and;
- Genetic testing and such like alerts breeders to potential problems in their lines, thus an informed choice can be made by breeders without fear of repercussion, and
- This motion does not compel usage of particular dogs in the gene pool, however it does allow freedom of choice for those that would include particular dogs in the gene pool.

2. (Submitted by NSW)

The NBCC request that the decision made at the meeting of the National Breeds Standards Committee held on Saturday 20th October, 2007 at the Citigate Central Sydney Hotel, 169-179 Thomas Street, Haymarket, New South Wales on the motion of D Sales/S Mills that the ANKC write to the FCI advising the FCI that as the ANKC was the Country of Development for Border Collies that the FCI should adopt the ANKC Breed Standard for the Border Collie NOT the Kennel Club (England) be rescinded.

Rationale:

The ANKC made this decision without consultation with the NBCC and has based the motion on inaccurate information regarding dates that the first breed standard and the first Australian and UK standards were introduced. The Australian Border Collie Standard discriminates against colours which are main registered in every other country of the world as well as discriminating against ear carriage and coat length that are acceptable in other countries. The ANKC recommends that NATIONAL BREED COUNCILS recommendations & breed surveys are necessary before decisions are made yet did not consult the NBCC on this motion which is highly significant internationally.

3. (submitted by NSW)

That the NBCC request the decision made by the National Breed Standards Committee/Coordination Group on October 21st, 2006 to limit register BORDER COLLIES of non-standard colours be rescinded.

Rationale:

The information paper ANKC POLICY on what colours are to be registered for different breeds cites that it follows in principle the KENNEL CLUB(ENGLAND) system. Minutes from the NATIONAL BREED STANDARDS COMMITTEE meeting held on the 21st October 2006 state Mr Gent confirmed Caroline Kisko of the Kennel Club of UK had confirmed the following: "Essentially we register colours exactly as people write them on the form (i.e. whether they are standard or non standard). The only exceptions to this are when the breed gets together and asks us to limit colour registrations to those in the standard. Once these colours are agreed with the breed (all clubs have to agree) and with our Breed Standards Committee, then we limit registrations to those colours. If anyone tries to register a non standard then we ring them or send the form back and tell them to change to the standard colours. The final resort is simply to register as 'non standard colour' – which is how it appears in the register and on pedigrees. Most people don't want this so they conform!! This has been done for a few breeds so far and is available if breeds get their act together."

It was unanimously RESOLVED on the motion of P Frost/M Jones for the ANKC Administrator to forward a copy of the Kennel Club of UK email advice to the NBSCG to assist them in forming a draft policy.

It was unanimously RESOLVED on the motion of M Hammett/M Jones for the draft policy by the NBSC to be electronically circulated to all member bodies.

The National Border Collie Council has not been consulted regarding limit registration of non-standard colours nor has it requested that his policy be implemented. ANKC appears to have mis-interpreted the KENNEL CLUB (ENGLAND) policy and erroneously limit registered non-standard colour border collies. ANKC have not followed it's own recommendations.

There are no disqualifying faults stated in the border collie breed standard therefore a variation of standard colour/s is not a disqualifying fault. A dog which is a non-standard colour is no less worthy of inclusion on the main register than one which as a level bite, almond eyes, hare-feet or large ears. The Australian breed standard states any departure from description in the standard to be considered a fault and the seriousness with which the fault should be regarded should be in exact proportion to it's degree no mention is made of disqualification. Dogs with uneven wear from level bites attain Australian Champion titles and are used for breeding, yet dogs with sound bites of non-standard colours **are discriminated against. ANKC limit registration policy regarding non-standard colours** fails to acknowledge the importance to some members of performance sport aptitude in the breeding programs. There is semen in storage in Australia from International Obedience Champions which are not recognized colours in their breed, the usefulness would be lost if their non-standard colour progeny could not be used in future breeding programs.

Many international standards conflict with our standards in Australia in regard to colours; to restrict breeding to dogs of standard colours reduces the potential for genetic diversity and improvement of the breed. It also causes breeders to place more emphasis on breeding for standard colours than correct breed type, soundness of temperament and working instinct. Because of current ANKC policy regarding the downgrading of non-standard coloured dogs when being imported we may have a scenario where a best in show at Crufts or Westminster is limit registered never to be up-graded when entering Australia, if the dog were to leave Australia it could not be issued an Export Pedigree. It is also un-acceptable that non-standard coloured dogs which are to be exported to a country which recognizes a colour which the ANKC does not can not be registered on main register to enable them to be registered in the country to which they are exported. An Australian Obedience or Tracking champion which was limit registered can not receive an export pedigree even if it is desexed.

Format of Competition

Each class has its own point score, i.e. Novice, Open and Utility. Handlers are required to submit the following;

1. Qualifying scores (total of three) for the desired class
2. The qualifying scores must be achieved by the handler working his own dog.
3. The 3 scores must be achieved by the same dog.
4. Only 1 score card may be submitted under a particular judge. In the event of multiple exhibits owned/worked by the same handler each dog is required in their total of 3 scores to have achieved these under 3 different judges.
5. Competitors must be financial members of the BCC of NSW Inc prior to the date of the earliest calendar dated qualifying score submitted, and must remain financial members of the BCC of NSW Inc during the running of the competition.
6. The twelve month qualifying period will commence from 1 September 2007 and cease on 31 August 2008.
7. In the event of a tied point score, the exhibitors will be asked to submit a further qualifying card until a winner is determined.
9. Photocopies of the qualifying cards must be sent to the **Secretary, Border Collie Club of NSW by 14 September 2008.**
10. A summary of the aggregates for each class will be published in the next available Bordertales and awards made as soon as possible.
11. The decision of the Committee is final, and no correspondence will be entered into.
12. Failure of the competitor to fulfil all the criteria listed above will render their entry null and void.
13. This competition does not require an entry fee.

The 2007/2008 competition is now underway with the qualifying period being 1 September 2007 to 31 August 2008. Competition rules will be published at frequent intervals in Bordertales.
